# **Donald Trump.** What can I say!

#### **Statewide Ballot Measures**

"Bonds are borrowed money that must be paid back, plus interest, even if that means cutting vital programs to do it." - Howard Jarvis Taxpayer Association.

Proverbs 22:7 - "The rich rule over the poor, and the borrower is the servant to the lender."

In principle, I don't believe bonds (new taxes) are the best way to raise revenues. Balance the state budget!

# Proposition 2. NO! A Bond that authorizes California to borrow \$10 BILLION for construction and repair of public schools and community colleges.

Voters rejected Prop. 13 in 2020 - a \$15B school bond. Let's do the same in 2024!

The State is coming at us again - this time for \$10B *plus* another \$8B in interest over 30 years! California already has \$109B in outstanding and unissued bonds as well as \$200B of unfunded pension liabilities and pension medical benefits.

Don't fall for the same old rhetoric "we need billions more to fix leaky roofs, unsafe drinking water, mold and asbestos and lead paint." The schools get 40% of the state budget but it never goes for the children. The Teachers Union gets most of that and then local schools then put bonds on the ballot for updating school facilities by taxing your property. That sounds like double jeopardy! Instead of always wanting money that never goes to fix anything, The State is now including funds for building housing for teachers.

CA schools are in the lowest percentile of all school districts in the nation ranking in the bottom 10. Let's spend our money on our children! Get back to teaching reading, writing, math, science and citizenship. No new taxes!

#### Proposition 3. NO! Repeals Prop. 8 and establishes the right to marry anyone.

This amends California's Constitution and will remove Prop. 8's language stating that marriage is only between a man and a woman and replace it with marriage to *any person*. This harmful measure could risk the civil rights of children and even open the door to child brides, incest, and polygamy (marriage between more than two people). **Genesis 1: 27, 28** states that "marriage is between a man and woman for the purpose of multiplying and filling the earth." **Vote NO on Prop. 3.** 

# Proposition 4. NO! Another reckless \$10 BILLION Bond measure for [unprovable] climate programs.

But wait! Don't they say this is for safe drinking water and wildfire prevention, as well as protecting natural lands from climate change? This bond could have been averted 2 years ago by paying for it from the General Fund when we had a \$100B surplus. Forest management and water supply have been neglected and mismanaged resulting in increased wildfires and water shortages. Prop. 4 does not solve the problem. **Vote NO.** 

Proposition 5. NO! Local bond measure that would lower the voter threshold from 66+% to 55% (in our constitution since 1879) to fund low-cost housing and public infrastructure. That is a direct hit to the Property Tax Protection of Prop. 13.

Why would you vote for a lower approval rate so that the state government can pass the costs of state programs to local taxpayers more easily? The state government hopes to quickly pile on billions in new taxes and debt, so you could see your property taxes shoot up right away. They want us to pay for low-cost housing and other infrastructure with higher property taxes. You will have to accept higher property taxes, higher rent, higher costs to farmers and businesses. Consumers would be hit with higher prices on everything from food to gas to utilities and services. Californians already have the highest cost of living in the nation. The state government has been spending your money for free health care, education, and food for illegal immigrants. Newsom has spent billions on the homeless, free abortions for all Medi-Cal patients, and free abortion pills in California State Universities. California has more state and local debt than any other state, now more than \$500 billion! Because of wasteful spending, they turned \$100 billion surplus into a \$73 billion debt in two years!

Beware of the fine print of this measure. It would make Prop. 5 *retroactive*. Any other bond passed this Nov. ballot (we have Prop. 2 and 4 on the ballot) would only need the lower vote total to pass. Don't be the next family that needs to move out of California. **Vote NO.** 

Proposition 6. NO! A Constitutional Amendment that will eliminate the state's requirement for criminals (not "incarcerated persons") to work. Prisoners will also be allowed to unionize, and demand pay raises from taxpayers.

It costs Californian taxpayers \$133,000 per year per prisoner and only one-third of them work now. Most of the jobs they do are cleaning their cells and common area, laundry, food preparation and other tasks to run the prisons. If Prop. 6 passes, taxpayers will have to pay more for criminals to voluntarily do these tasks. Meanwhile, those that choose not to work can spend more time working out, selling drugs, and participating in prison gang activities. Since thieves are no longer incarcerated, hardened criminals are left to threaten, intimidate, and harm other prisoners.

The Democrat Party of CA and the Liberal American Civil Liberties Union (ACLU) supports Prop. 6. **Vote No!** 

Thess. 3:10 "If a man will not work, he shall not eat."

# Proposition 32. NO! Another minimum wage increase to \$18 per hour. One leftist, progressive multi-millionaire, Joe Sandberg, bankrolled this initiative: https://www.joesanberg.com/advocacy

It would make California minimum wage the highest in the nation by almost \$2! State law already has a higher wage - \$20+ for many workers in fast food. Inflation has caused fast food prices to go up 7% in six months. Small business, the backbone of the middle class, will be forced to shut down costing jobs to the most vulnerable workers. Many leading voices for working families and voices for a higher minimum wage urged Sanberg to pull Prop 32. He refused! This bill will cost the state and local government billions of dollars each year.

# Proposition 33. NO! Increases the ability of local government to pass rent control laws while restricting private property rights.

Here we go again for the third time. 60% of California voters rejected the same rent control measure in 2018 and 2020. Some of the reasons to vote NO AGAIN:

- It will make the housing crisis worse by limiting the amount of new affordable housing.
- It will make it more difficult to own a home or find a decent place to rent.
- It provides no protection for seniors, veterans, or the disabled.

Some of the supporters: The California Democratic Party, Housing is a Human Right, and American Federation of Teachers (AFT).

# Proposition 34. YES! Requires health care providers to spend 98% of revenues from federal discount prescription drug programs on direct patient care.

- It saves taxpayers millions of dollars every year.
- Prevents legal loopholes for corporations from diverting money to fund political campaigns, housing projects and giving executives multi-million-dollar salaries.
- Holds healthcare providers accountable for spending 98% on direct patient care or losing their tax-exempt status and professional license.

# Proposition 35. NO! Permanently authorizes a tax on managed care organizations to fund Medi-Cal programs.

No tax should be permanent for any organization that is paid for by taxpayers, including Medi-Cal. A better solution can be arranged to provide more funds for Medi-Cal.

# Proposition 36. YES! Allows tougher laws to Make Our Communities Safer and Punish Repeat Criminals.

This will make the justice system fair for everyone and hold criminals accountable for their crimes, while helping drug addicts get necessary treatment.

Ten years ago, Prop. 47 was passed to supposedly lower prison population by reducing felony theft and drug crimes to misdemeanors. How has that worked out? "Smash-and-grab" crimes have exploded. Fentanyl trafficking kills more people than car accidents. There are no serious consequences and thieves are arrested and let go or not arrested at all. Businesses have had to close or move. Prop. 47 instituted DEI (diversity, equity and inclusion) into the decision of who to arrest. As a result, it punishes the victims instead of the thief because of their racial ethnicity. I think DEI should be named (divisiveness, exclusion, and indoctrination). There should be equal justice for all under our Constitution. **Vote YES.** 

#### **City Ballot Measures**

### Mission Viejo - Measure Y. NO! Municipal Tax on Hotels increasing from 8%-12%

Mission Viejo voters will consider an increase to the Transient Occupancy Tax (TOT) charged to out-of-town guests staying at the city's hotels and short-term rentals.

In principle, cities should not be involved in supporting tax hikes. Assessment taxes should not be raised 50% for hotels and short-term rentals to help our budget. It will drive customers to nearby cities, thus making it harder to make a profit in Mission Viejo.

Mission Viejo is a low crime city and should not need to raise money to pay for the Police Department. Yes, we the taxpayers of Mission Viejo are not paying this tax, but travelers, family members and Olympic guests will! Vote No!

Note: the average rate in Orange County is 10%. There are only five cities with a 12%+ tax: La Palma, Buena Park, Laguna Beach, Seal Beach, and Staton. All our immediate neighboring cities are 10% and five cities with an 8% rate.

San Clemente - Ballot Measure BB. NO! 1/2% sales tax for replacing beach sand.

**NO!** Mismanagement of funds for the city's hill and land development should not be passed on as an extra burden to taxpayers.

# Dana Point - Ballot Measure T. You decide! Shall residents change the 2023 ordinance or keep it?

**Yes vote**: Reduce Short Term Rentals (STR) by 50%. Requires permits to be given annually. Changes require an election with a vote of the people and the California Coastal Commission.

**No vote:** Short term rentals occupancy tax will be reduced from \$725,000 to \$450,000. The annual permit lottery will create uncertainty for owners and eliminate advanced bookings. The City Council can change the ordinance at any time and is required to review it every 3 years.
